COVID has impacted the functioning across all sectors and left people in a state of constant anxiety, insecurity, and stress.</p> <p>This Talk is intended to address and highlight the concern of unmet needs for mental health and to prepare for future challenges in the post pandemic era in terms of prevention and management.</p>

	<p>India is hugely short of healthcare workforce and way behind in achieving the targeted doctor population ratio of 1:1000, as per WHO norms. Moreover, the need for larger workforce got ascertained during the second wave where the hospitals fell short of doctors and nurses leaving only one-third of the workforce available to cater to the healthcare needs. Addressing near-term workforce challenges arising from COVID-19, while building workforce adaptability is important to build a resilient primary healthcare system. Upskilling of the existing workforce and building a stronger set of allied healthcare professionals can prove to be a strategic intervention.
