
- Prof Baghel is the Hon'ble Minister of State for Ministry of Health & Family Welfare, Government of India.


- Ms Amrita Sekhar is a Senior Program Officer, Innovative Health Tools at the India Country office of the Bill & Melinda Gates Foundation.
